Introduction

As America enters a New Year and New Decade, President Trump 45 will face some earth shattering events in his next term that will shape most of the 2020s and beyond.

President Trump's impeachment trial in the Republican majority Senate will end with his acquittal, as stated in Parts 1-3 on the subject.

This paper will examine seemingly unrelated events that occurred after the last two Impeachment trials. Most American pundits have overlooked these events. Few understand that all events are related in accordance to the divine purpose, plan of Yahweh Elohim.

For example, the lamb killed in Egypt (Exo. 12:1-2; Isa. 53:7-8; John 1:29) seems unrelated to the Messiah, as was the lion killed by Samson on his way to a wedding (Jud. 14:5-6, 8-9; Rev. 5:5; 10:9-10) and later when he returned to the scene the lion carcass had a beehive with honey in it.

Unless one receives a revelation from the Holy Spirit no one can understand how the lamb, lion, beehive and honey are related to the Messiah. The clues lies with the mission of the Messiah in that He is fulfilling the law and prophets (Mt. 5:17-18, Lk. 24:44) or Old Testament and the Messiah is lion from the tribe of Judah according to Book of Revelation (Rev. 5:5).

What followed each impeachment trial was a war and an economic collapse that seems unrelated to historians of American history.

There were a pattern of events that occurred after each Impeachment trial because it followed the pattern of events surrounding the greatest trial of the ages, Yahshua (Jesus) Messiah, Pontius Pilate, Herod, and leaders of Israel.

Spiritual Civil War and Israel's Economic Set Back

After the death, burial, resurrection and the outpouring of the Holy Spirit in 33 AD, in Jerusalem (Acts 2:1-14), the Apostles began preaching the gospel and began the spiritual civil war with the religious leaders of Israel. This spiritual civil war (2Cor. 1-4) was over

who was keeping the Old Covenant (feasts days, sacrifices, suppers, etc. Col. 2:11-17), which was no longer valid after the death of the Messiah (Rom. 10:4, Heb. 8th-9th chap. In other words, it was a war between those worshiping the Heavenly Father in spirit and truth (Jn. 4:24) in this Present Kingdom Age of Grace and those that denied the Messiah. Many believers were scattered out of Jerusalem except the Apostles (Acts 8:1-2) by this spiritual war.

With the Old Covenant ended, Israel's economy suffered a great set back. The buying and selling of sacrifices, celebrating feast days, keeping suppers, and supporting the priesthood ended since they were no longer needed for salvation. A business had developed around all of these rituals.

For example, the *guest room* where the disciples kept the last Passover supper (not the Lord Supper) with the Messiah (Mk. 14:12-17), was rented. Rooms were sold with all the accouterments needed for visitors to keep the feast days, and buy sacrifices (Mk. 11:15). This was occurring in the temple when the Messiah cast out the money changers.

The non-believers in the Messiah continued to offer up sacrifices and keep the feast days, etc., until the Roman leader Titus tore down the temple in AD 70.

It's these principles of war and economic slow down or recession/Depression that occur after each of the previous Presidential impeachment trials where they were acquitted.

After President Trump 45's soon to be acquittal and his reelection, he will also face the greatest economic depression in human history due to the US and world record debt and the Civil War brewing, after the defeated of the presidential Democratic candidate Hillary Rodham Clinton in the 2016 presidential election.

Let us now look at the previous acquittals of Presidents to see how the pattern of events follow the Messiah's trial.

Pres Andrew Johnson Democrats 17th 1865-1879

Reconstruction

Political turmoil in this era was very tumultuous with the end of the civil war (1861-1865) and President Lincoln 16's assassination and his replacement by a Democratic Vice President Andrew Johnson.

The turmoil centered on the reconstruction of the southern states back into the Union and the disposition of the slaves which were freed by President Lincoln.

In brief, the majority House of Representatives were Republican, called the Radical Republicans, whose policy of Reconstruction and slaves clashed with President Andrew Johnson's, a Democrat of Tennessee.

President Johnson's policy gave more leniency and accommodations toward the southern states that committed treason and left the union, which concurred with President Lincoln's views.

The Radical Republicans wanted the southern states to receive severe penalties for treason and withdrawing from the union.

The other issue was the free slaves and their civil rights. The Radical Republicans wanted to give the freed slaves their civil rights rights to vote and run for office, which upset the Southerners.

Southerners in turn formed the KKK, which President Grant 18 dealt with during his administration getting the first Civil Rights bill and Constitution Amendment passed.

Now President Johnson was apprehensive of civil rights for the slaves, but the radical Republicans had a super majority in 1866 in

both Houses of Congress House and Senate. They could override his veto and ratify the **Fourteenth Amendment**, and guarantee voting rights for black males. It forced the southern states to change their constitution and ratify the **Fourteenth Amendmen**. For details of this period see the link above in Wikipedia wastage.

Now the Panic of 1873 Depression happened after President Johnson left office and occurred during President Ulysses Grant 18th (1869-1877) term.

“After the Civil War, the US banking system grew rapidly and seemed to be set on solid ground. But the country was hit by many banking crises. One of the worst happened in 1873 – during the time of the Freedman’s Bank.

The panic started with a problem in Europe, when the stock market crashed. Investors began to sell off the investments they had in American projects, particularly railroads. Back in those days, railroads were a new invention, and companies had been borrowing money to get the cash they needed to build new lines. Railroad companies borrowed using bonds, which were debt securities specifying how much a company was borrowing and how much interest it would pay..“

President Grant Indian War

President Grant promised peace with Indians — and covertly hatched the plot that provoked one of the bloodiest conflicts in the West. This was primarily due to the gold that was in the Dakota, which was part of the Indian Lakota territory. *“Quoting the below article In July 1874, Lt. Col. George Armstrong Custer led a thousand-man expedition into the Black Hills, in present-day South Dakota. He was under orders to scout a suitable site for a military post, a mission personally approved by President Ulysses S. Grant, but he also brought along two prospectors, outfitted at his expense. Although largely unexplored by whites, the Black Hills were long rumored to be rich in gold, and Custer’s prospectors discovered what he reported as “paying quantities” of the precious metal. A correspondent for the Chicago Inter Ocean who accompanied the expedition was less restrained in*

his dispatch: “From the grass roots down it was ‘pay dirt.’” Taking him at his word, the nation’s press whipped up a frenzy over a “new El Dorado” in the American West. The United States was going into the second year of a crippling economic depression, and the nation desperately needed a financial lift. Within a year of Custer’s discovery, more than a thousand miners had streamed into the Black Hills. Soon Western newspapers and Western congressmen were demanding that Grant annex the land....”

President Clinton 42nd 1992-2000

President Clinton was Impeached for "high crimes and misdemeanors" by the Majority Republican House in Oct. 1998 and acquitted in the Trial 1999. Quoting from the wikipedia below.

“The specific charges against Clinton were lying under oath and obstruction of justice. The charges stemmed from a sexual harassment lawsuit filed against Clinton by Paula Jones and from Clinton's testimony denying that he had engaged in a sexual relationship with White House intern Monica Lewinsky. The catalyst for the president's impeachment was the Starr Report, a September 1998 report prepared by Independent Counsel Ken Starr for the House Judiciary Committee.”^[1]

Recession 2000-2001

Following President Clinton’s second term President George Bush 43 was elected and face dot collapse of the stock market , recession, 911 terror attack, Invasion of Iraq War and Afghanistan.

Quoting the link below “After the relatively mild 1990 recession ended in early 1991, the country hit a belated unemployment rate peak of 7.8% in mid-1992. Job growth was initially muted by large layoffs among defense related industries.^[2] However, payrolls accelerated in 1992 and experienced robust growth through 2000.^[3]

Predictions that the bubble would burst emerged during the **dot-com bubble** in the late 1990s. Predictions about a future burst increased following the **October 27, 1997 mini-crash**, in the wake of the **Asian crisis**. This caused an uncertain economic climate during the first few months of 1998. However conditions improved, and the **Federal Reserve** raised interest rates six times between June 1999 and May 2000 in an effort to cool the economy to achieve a **soft landing**. The burst of the stock market bubble occurred in the form of the **NASDAQ crash** in March 2000. Growth in **gross domestic product** slowed considerably in the third quarter of 2000 to the lowest rate since a contraction in the first quarter of 1992.^[4] The NBER's Business Cycle Dating Committee has determined that a peak in business activity occurred in the U.S. economy in March 2001. A peak marks the end of an expansion and the beginning of a recession. The determination of a peak date in March is thus a determination that the expansion that began in March 1991 ended in March 2001 and a recession began.^[5] “ https://en.wikipedia.org/wiki/Early_2000s_recession
