Scripture Lesson: Acts 24:5
Topic: The Trial of the Century
(Trump Impeachment) By The Pattern, P. 2

Acts 24 1 And after five days Ananias the high priest descended with the elders, and with a certain orator named Tertullus, who informed the governor against Paul. 2 And when he was called forth, Tertullus began to accuse him, saying, Seeing that by thee we enjoy great quietness, and that very worthy deeds are done unto this nation by thy providence, ... 5 For we have found this man a pestilent fellow, and a mover of sedition among all the Jews throughout the world, and a ringleader of the sect of the Nazarenes: 6 Who also hath gone about to profane the temple: whom we took, and would have judged according to our law. 7 But the chief captain Lysias came upon us, and with great violence took him away out of our hands, ...

Introduction

In “*The Trial of the Century, Part 1,*” PLIM defined the essence of what the US Constitution Presidential impeachment process reflected from a divine metaphysical standpoint. Impeachment is a spiritual principle that has its physical counterpart (ROM. 1:19-20) like everything else In the physical realm.

It is not our purpose here to examine blow by blow or witnesses by witnesses the Democrat's impeachment trial of President Trump in the House of Representative nor the subsequent trial in the Senate, but to highlight the metaphysical principles involved.

Impeachment Process Three-fold By The 3-Fold Tabernacle Pattern

Now the impeachment trial is a 3-fold process by the tabernacle pattern found in the Law of Moses and the US constitution. It consists of a judicial body that determines the following by the pattern.

1. Charges of the Law Broken - Most Holy Place (MHP
Laws placed in the Ark of the Covenant)
2. Interrogation & Trial - Holy Place - HP
3. Verdict, Penalty, Execution - Court Round About-CRA

Now all three government bodies play a role in this impeachment process; the Executive Branch is Charged, the House of Representatives bring charges, the Senate holds the trial, and the Chief of the Supreme Court Judge oversees it.

Today in US courts these are the elements of "due process". Even in an unjust system these elements are still in play.

Now the execution of these principles in the impeachment process are laid out in US Constitution, the law of the land.

When this article was posted on Facebook initially, someone asked the following questions:

1. Would the President Trump impeached?
2. Would He be assassinated?
3. Would He be reelected?

My response follows.

To answer some questions of whether Trump will be impeached, killed, or re-elected require proof and an understanding of Daniel's Prophecy 1260, 1290, 1335 (Dan. 12:11-12) and President Trump's number. The number of Trump's Presidency is 45 which means he is the 45th president of the US. Each president's number reveals his purpose. See the article I posted to Facebook November 18, 2018 called "WWI & WWII Presidents & President Trump By the Tabernacle Pattern." President Trump's presidency represents Pentecost because 45 in Daniel's prophecy must be added up to the 1290 to get 1335. (Dan. 12:11-12)

Now 1260 days is the 3 1/2 years of the Messiah's ministry. 1290 is 1260+30, the Messiah's age when he entered His ministry = 33 years of Yahshua's life at His death. Thus, 1335 is 1290+45, the day of Pentecost.

Knowing the number of the president, you can answer the questions. Pres Truman is the 33rd President which is the same as 1290 and President Trump is 45 as Daniel is 1335 in Principle. They fulfill Daniel's prophecy which is a repeat of Yahweh's purpose.

Answers to questions:

Trump will be impeached by the Democratic House, but he will not be convicted in the Republican Senate trial. He will be re-elected and establish a new economic system that will remove the OLD US DEBT or declare PENTECOST.

There has not been a president killed since JFK 35th, elected in 1960. He was the seventh president killed since 1840 on the 20-year cycle. Remember, 1960 begins a probationary period which we have been in for the last 60 years.

There has never been a president removed from office through the impeachment process although, there has been three attempts.

Many may ask why haven't there been any presidents successfully removed from the office of Presidency by impeachment. The pundits and politicians will believe it was due to parties loyalty, politics, not knowing this reflects the purpose of Elohim.

The three impeachment charges of the three presidents by the House of Representatives were always brought about by the majority party at the time. For example, the majority Republican Party brought two impeachment charges against two democratic presidents: President Andrew Johnson 17th and President Clinton 42nd. Currently charges of impeachment are being brought against Republic President Trump 45th by the Democratic majority. Keep in mind all this goes according to the tabernacle pattern.

As stated in Part 1, the impeachment trial reflects Yahshua the Messiah's trial that proved his innocence and resulted in a New Order or Covenant (Jer. 31:31-43) that followed after His death, burial, resurrection and the outpouring of the Holy Spirit. Few will accept this account, but history shows each president impeached had some form of a new order after the trial, which followed the purpose of Elohim.

When did the spiritual Impeachment process begin?

The Spiritual impeachment principle originally began in heaven, after Yahweh Pure Spirit took on the form of

Elohim, in part, known as the Beginning of creations and created the angelic creation with their various orders, including Lucifer.

Note: Lucifer was created with an enormous array of talents, such as intelligence, wisdom, knowledge, beauty, etc., more than any other angel. Now Lucifer was typified in the physical realm by the Prince of Tyre (Ezk. 28:1-20).

Because of Elohim's purpose, Lucifer's heart was hardened by pride. He exalted himself above Elohim (Isa. 14:12-15), the Creator, and Lucifer began a revolt in heaven to overthrow the divine established order setup by Elohim. Lucifer's reign established seven kingdoms (Rev. 12:3) that ruled for a period of time.

Then Lucifer was found guilty by Elohim's heavenly court and the archangel Michael was given power to cast him out which executed the impeachment process that removed Lucifer and his angels from their positions/offices by war. Michael cast them out of the angelic creation into the unfinished heavens and earth (Rev. 12:7-10).

This was the origin of the first impeachment process.

Dr. Kinley says Lucifer was found guilty in a heavenly court that Elohim judged. See Elohim Text, Vol. 1,

“YAHWEH IS SUPER INCORPOREAL FORM (ELOHIM)”
p. 27-28.

*“Angels are MINISTERING SPIRITS, created to Serve, Honor, Obey and Glorify Yahweh (see Daniel 3:28; 7:27; Luke 1:19; Hebrews 1:14). Lucifer, an angelic spirit creature, the Son of the Morning, because of his great Beauty and Wisdom, wherewith Elohim had created him, lifted himself up or rebelled against Yahweh. This caused a rebellion in Heaven among the Angels, **and therefore, Lucifer and his host were found guilty before Elohim, and were cast out of Heaven into the Ethereal Darkness that surrounded the Earth after the beginning of the physical creation. This was the ORIGIN of Satan, the Evil Spirit Creature.**”*

Although this angelic court is not detailed in the scriptures, Micaiah, the son of Imlah, the truthful prophet, referenced Yahweh’s heavenly court in 1Kings 22:19-22 when he prophesied Israel’s defeat by Syria.

Simply put, the impeachment process is the removal of one from office or position due to some unlawful activity.

The impeachment trials under the U.S. Constitution of the three presidents, the highest office in the country, were physical reflections of the greatest impeachment trial through the ages with Yahshua the Messiah.

The three presidents in each century by the Tabernacle Pattern: 19th Century - President Johnson 17th - CRA, 20th Century - President Clinton 42nd - HP and the 21st Century - President Trump 45th - MHP, represent the

impeachment principle in each the of the three ages in time, Ante, CRA & Post Diluvian, HP and the Present Kingdom Age of Grace thru Faith, MHP.

Does the US Constitution reflect the New Covenant?

Yes it does. It must be understood that the US Constitution reflects the New Covenant where men were given certain certain freedoms as 2 Cor. 3:17 states: *“Now Yahweh is Spirit, and where the Spirit of the Yahweh is, there is liberty.”* This was the first document in the history of men that allowed men to be governed by elected officials for the people and by the people with Elohim given rights.

Now it must be understood that from AD 34 in Jerusalem when the Holy Spirit was poured out till 1776 AD when the Bill of Rights was written, men were governed by monarchs with divine rule where there were no rights for the commoners.

Now freedom is defined as inalienable rights from Elohim in the Bill of Rights and the US Constitution. It should be noted that prior to the US Constitution as stated above, men were governed by kings with no freedom and kings could not be impeached because of their divine right to the throne.

Wikipedia says The **divine** right of kings, or **divine**-right theory of kingship, is a political and religious doctrine of royal and political legitimacy. It asserts that a monarch is

subject to no earthly authority, deriving his right to **rule** directly from the will of God.

As was pointed out in Part 1 of this discussion, the impeachment trial of Yahshua the Messiah setup a new order of worship of Yahweh in Spirit or Truth (Jn. 4:24-25) under the New Covenant by Grace thru Faith.

Impeachment in the Law and Prophets

There are numerous examples in the Scriptures (Law & Prophets) showing forth the principle of impeachment from office or removal from Israel's office by Yahweh Elohim for transgressions of His Laws as revealed to Moses.

In the law of Moses, Yahweh impeached the first priests from office for they offered up strange incenses on the altar (Ex. 30:8). It was Nadab and Abihu, Aaron two sons that offered up strange incense before the presence of Elohim and was consumed (Lev. 30:1-2). This pointed to offering up strange incense (prayers) to a false deity like the Virgin Mary. The only True intercessor is Yahshua the Messiah (I Tim. 2:5) under the New Covenant (Heb. 8-10).

Now in the prophets, King Solomon was impeached from his office of Kingship of Israel for worshipping various gentile gods (1Kgs. 28:1-9). They were Ashtoreth the goddess of the Zidonians, Chemosh the god of the Moabites, and Milcom the god of the children of Ammon.

Scripture states “Wherefore Yahweh said unto Solomon, Forasmuch as this is done of thee, and thou hast not kept my covenant and my statutes, which I have commanded thee, I will surely rend the kingdom from thee, and will give it to thy servant (1 Kgs 28:11).”

Elohim said through the prophet Ahijah the Shilonite (Shilo Levite priest) the first King Jeroboam would be king of northern Israel, which divided Israel into two parts Northern & Southern tribes at King Solomon’s death. See also 1 Kgs. 28:29-32.

Have New Orders Historically Followed Impeachments?

Part 1 of the impeachment trial of the 21st century of President Trump showed that the new order would be a Jubilee coming when the Greatest Depression occurs in Trump’s next term when he resets the US debt and finances. This would be a repeat of Yahshua the Messiah establishment of the new order, Jubilee, being the New Covenant and the removal of the Old Covenant. Part 1 of the impeachment trial of the 21st century of President Trump also showed how divided the country was between the Democrats and Republicans. This was a

repeat of a division between the Sadducees, Pharisees and the followers of Yahshua Messiah that existed during Yahshua the Messiah's ministry.

The question that arises in this impeachment trial of President Trump is will there be some type of division in the 50 states? Did you know a group of California citizens wants to break away from the rest of the state, the urban centers, and form "New California," the rural areas of California (See the two websites <https://youtu.be/iNu6EGj8wiQ>, <https://youtu.be/LCXtCG7ptSc>)

The greatest depression in this century, greater than the one in 1929, will follow President Trump's impeachment trial and reelection to his second term which will bring about a new order.

Let us look at some examples of the two other impeached Presidents.

Vice President Andrew Johnson was appointed the 17th president, after the assassination of President Lincoln 16th and after the civil war. He favored the restoration of the southern states to the Union reflecting the restoration of spiritual Israel after Yahshua's trial and His death, burial, resurrection and the out pouring of the Holy Spirit.

To show forth the civil war was an end of a cycle or era, President Andrew Johnson bought Alaska from Russia for \$7.2 million, which later became the 49th state in 1959, at the end of the age in 1960.

Now this 49th state correlated with the outpouring of the Holy Spirit, which ended with the 490 cycles (Dan. 9:24-25), fulfilled by the Messiah, who ended the Post Diluvian Age and began the Present Kingdom Age Grace thru Faith.

All three Impeachments Happen During Bitter Divisions Between the Executive and Congressional Branches

As stated earlier, the country was divided along political lines, but few understand the Congressional and Executive branches were bitterly divided and was one the primary reasons for the three **impeachments**.

Israel was also in like manner divided, the priests oversaw the ministration of the Law and the Romans were the final authority with Pilate.

President Andrew Johnson 17th became president after Lincoln's assassination. He wanted to bring the south back into the union with leniency by having them pledge allegiance to the US, giving favor to the wealthy and those with property. He did not give protection to the former slaves. The Radical Republicans, who favoured severe

measures toward the defeated yet largely impenitent South, wanted to punish the South. It was the Radical Republicans in 1866 that made Negroes citizens of the US, prevented discrimination and passed the **Fourteenth Amendment** in 1868 which Johnson was cool toward. Clinton sowed the seeds for several controversial issues and caused a division that resulted in the 2001 Patriotic Act which profoundly changed American travel and rights within the US and internationally.

“Despite several notable accomplishments in his first years as president, including the Family and Medical Leave Act of 1993, the implementation of the "Don't Ask Don't Tell" policy for LGBT military personnel and the ratification of the North American Free Trade Agreement (NAFTA), Clinton's first years in office left him politically vulnerable. Through a task force headed by First Lady Hillary Clinton, Bill Clinton endorsed a massive health care

reform act that was designed to provide universal coverage. The bill failed to move through Congress, however, and became a massive political disaster, leading to Republicans regaining control of both houses of Congress in 1994.

In an impressive political comeback, President Clinton again embraced centrist policies and rhetoric to restore his popularity in advance of the 1996 election. In 1994, he signed the Violent Crime Control and Law Enforcement Act, a law that added 100,000 policemen and instituted harsher punishments for a variety of crimes. [It locked up many innocent black men in for profit prisons.] In 1996, he signed a law increasing the national minimum wage. He also emerged favorably from a budget dispute with House Republicans that resulted in a pair of government shutdowns in 1995, the second of which lasted three weeks.

Clinton's greatest accomplishment in his two terms as president was leading the nation to a period of strong economic prosperity. While Clinton was in office, the nation enjoyed the lowest unemployment rates in decades, as well as a surge in median income and a rise in home-ownership rates.

Clinton's foreign policy achievements included presiding over the 1993 signing of the Oslo Accord between Israel and the Palestine Liberation Organization, during which

the famous handshake between [Yitzhak Rabin](#) and [Yasser Arafat](#) occurred, stabilizing war-torn Bosnia through the Dayton Peace Accords and helping to end Serbia's ethnic cleansing of Albanians in Kosovo. However the failure of the American military mission in Somalia and subsequent inaction in the face of genocide in Rwanda, both from Clinton's first term, stand out as major blemishes on his foreign policy record.”

The Constitution laid down the charges for the removal of the president, vice president and all officers of the US government

The President, Vice President and all Civil Officers of the United States, shall be removed from Office on Impeachment for, and Conviction of, Treason, Bribery, or other high Crimes and Misdemeanors.”

– U.S. Constitution, Article II, section 4

Now it is the House of Representative that brings charges against the President for impeachment. It is also a three-fold process by the tabernacle Pattern as we stated earlier.

The House impeachment process generally proceeds in three phases: (1) initiation of the impeachment process by a member of the House; (2) Judiciary Committee investigation, hearings, and markup of articles of impeachment; and (3) full House votes on consideration of the articles of impeachment.

“The House debates the resolution and may at the conclusion consider the resolution as a whole or vote on each article of impeachment individually. A [simple majority](#) of those present and voting is required for each article for the resolution as a whole to pass.” https://en.wikipedia.org/wiki/Impeachment_in_the_United_States#House_of_Representatives:_Impeachment

Now the trial for the impeachment is held by the Senate with the Chief Judge of the Supreme Court being the judge. The whole Senate must vote according to the Constitution which requires a two-thirds super majority to convict a person being **impeached**. The **Senate** enters judgment on its decision, whether that be to convict or acquit, and a copy of the judgment is filed with the Secretary of State. Currently, the Republicans have the majority in the Senate and the Democrat's need a two-thirds vote to impeach Trump which is impossible for them to get.

Conclusion

In conclusion, the impeachment process appears to be drawn up along parties lines headed by the party which was in control of the House of Representatives at the time. Twice, the Republicans impeached Democratic presidents in the case of President Johnson and Clinton and once the Democrats are now trying to impeach Republican President Trump.

It must be remembered that the Constitution was the first document that gave individuals rights (sovereignty) and a three-fold government: Executive, Legislative, and Judicial Branches, with laws to govern each branch as reflected by the 3-fold pattern of the universe.

In the purpose of Yahweh Elohim, laws were given to govern angels and men, but undermined by the adversary Lucifer. So this undermining must be reflected in the greatest documents of government revealed to mankind, the Constitution, which reflected the New Covenant in this Present Age of Grace by Faith.

The believers in the Old Covenant were constantly undermining the New Covenant, as in the case of the Apostle Paul before his conversion (Acts 9th Chapter). Thus, the impeachment of officials under the Constitution is a reflect of what happened in heaven with Lucifer and Israel's priests and kings under the law of Moses.

Now the question arises, why were the two presidents although impeached, not removed from office by the Senate (with the third one pending). One can see the Senate as a type of body that reflected forgiveness for sin (I Cor. 15:55) and the Senate also reflected Pilate finding the Messiah, the King of the Jews, innocent in fulfillment of the scriptures. The Scribes and Pharisees would be likened unto the House of Representatives that brought the charges.
